SECTION 4: First aid measures

4.1. Description of first aid measures

5.3. Advice for firefighters

- Firefighting instructions : Use water spray or fog for cooling exposed containers. Exercise caution when fighting any chemical fire. Prevent fire-fighting water from entering environment.

Remove all sources of ignition. Then wet area with acetonitrile and wipe up.

7.1. Precautions for safe handling

- Additional hazards when processed : Handle empty containers with care because residual vapors are flammable.

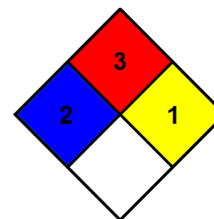
